#### RIPE Database

- RIPE DB Documentation updated with current features & implementations
  - Updated 'Getting Started' and 'Query Reference'
  - Created 'Update Reference' (draft)
- Fully implemented native IPv6 support in whois-servers
  - Interim proxy solution is now deprecated
- RIPE DB fully supports ASN32
  - 10 object types and 41 attribute types affected
- Crypt-pw authentication deprecation completed
  - Crypt-pw to md5 webform still available for late switchers
